


# **INVENTORY**


At this writing (June 05, 2023) we have 541 (-24) residential homes actively for sale in our area ranging from a low price of \$44,500 to a high of \$18,000,000. There are 63 (+03) properties in "Active Under Contract" status (some major contingencies but in escrow). There are 107 (+07) properties in a Pending sale (waiting on escrow to close). Of the active listings, 157 in the Yucca Valley zip code of 92284 (-03). 168 in the Joshua Tree zip code of 92252 (-02) and 135 in Twentynine Palms 92277 (-47).



## MONTHLY CLOSED ESCROW AND INVENTORY COMPARISON BY YEAR

Last month, in May, we closed escrow on 125 residential properties. In comparison, last year we closed escrow on 177 residential properties in our Hi Desert communities. Below are two, line graphs of inventory and closed escrow by month for the 2018, 2019, 2020, 2021, 2022, and 2023.





# WHAT IS AVERAGE?


Our Hi Desert communities offer a variety of custom housing. When I refer, in this Update, to "average" just what is the definition for that month? # LAST MONTHS CLOSED ESCROW INFORMATION


## **Number of Closed Escrows:**

Last month (May 2023) in our Hi Desert communities of Yucca Valley, Joshua Tree, and Twentynine Palms plus outlying areas we closed escrow on 125 homes (+24). 39% of the sold homes were in Yucca Valley, 23% were in Joshua Tree, and 28% were in Twentynine Palms, 10% were from the smaller communities that surround our larger ones.



#### **CLOSED ESCROWS BY PRICE RANGE:**


Of the 125 escrows closed in May, 44 were under \$300,000 (-02). 41 were between \$300k and \$400k (+15). 68% of homes sold under \$400k. 18 homes sold between \$400k and \$500k (+01). 18 homes sold between \$500k and \$750k (+10). 4 homes sold over \$750k (+/- 0). This month the highest value home sold at \$1,300,000 and is located on Cobalt in Yucca Valley.



# **HOUSING STATISTICS**


### **AVERAGE PRICE OF CLOSED ESCROWS:**

In May, homes that closed escrow in Yucca Valley sold at an average price of \$413,280 (-\$10,075), Joshua Tree averaged \$433,293 (+\$37,750), Twentynine Palms averaged \$264,357 (-\$13,512).




#### PRICE PER SQUARE FOOT OF CLOSED ESCROWS:

In May, homes that closed escrow in Yucca Valley sold for \$269.85 per square foot (-\$14.66), Joshua Tree sold for \$393.61 per square foot (+\$14.88), Twentynine Palms sold for \$222.08 per square foot (+\$9.58). The most expensive home sold by square foot this month is in Joshua Tree. This 1955 home has 720 square feet, on 5 acres, sold for \$1,020.83 per square foot, and is on Shadow Mountain. The least expensive home sold was \$102.27 per square foot and is in Twentynine Palms on Decker Rd.



## **Average Days on Market:**

The average days on market for sold homes in Yucca Valley in May was 81 (+04), Joshua Tree was 86 (-09), Twentynine Palms was 101 (+33).




#### MARKET CONDITIONS

I am sharing with you the Altos Market Trend Report. This is a weekly report provided to me that can shed light on the health of our market. I use the same week of each month that I prepare my Monthly Market Update to help inform you of the trends in our market. The Market Action Index (MAI) answers the question "How's the Market?" by measuring the current rate of sale versus the amount of the inventory. Index above 30 implies Seller's Market conditions. Below 30, conditions favor the buyer. Watch for changes in MAI. If the MAI resumes its climb, prices will likely follow suit. If the MAI drops consistently or falls into the Buyer's zone, watch for downward pressure on prices.


#### **YUCCA VALLEY:**

This week the median list price for Yucca Valley, CA 92284 is \$499,000 with the market action index hovering around 39. This is about the same as last month's market action index of 39. Inventory has decreased to 148. In the last few weeks the market has achieved a relative stasis point in terms of sales to inventory. However, inventory is sufficiently low to keep us in the Seller's Market zone so watch changes in the MAI. If the market heats up, prices are likely to resume an upward climb.



#### **JOSHUA TREE:**

This week the median list price for Joshua Tree, CA 92252 is \$529,500 with the market action index hovering around 30. This is about the same as last month's market action index of 30. Inventory has increased to 166. The market has shown some evidence of slowing recently. Both prices and inventory levels are relatively unchanged in recent weeks. Watch the Market Action Index for changes as it can be a leading indicator for price changes.



#### TWENTYNINE PALMS

This week the median list price for Twentynine Palms, CA 92277 is \$259,000 with the market action index hovering around 36. This is about the same as last month's market action index of 36. Inventory has decreased to 141. Home sales continue to outstrip supply and the Market Action Index has been moving higher for several weeks. This is a Seller's market so watch for upward pricing pressure in the near future if the trend continues.
